

How to vote against Saba

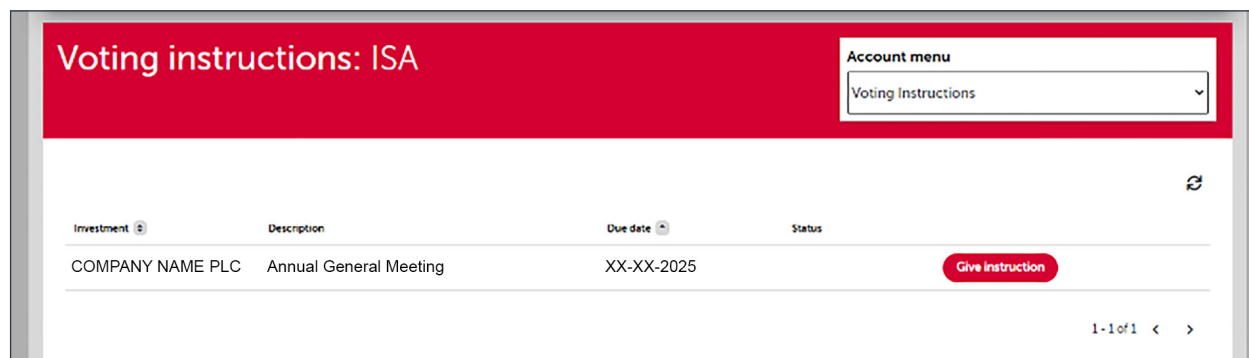
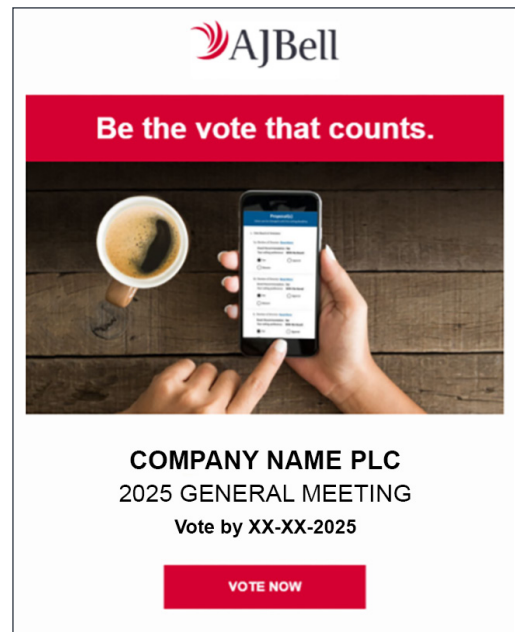
The voting process differs between the major platforms. We've outlined the voting process for each of the major platforms below, to make it easy for you to **vote against the proposed Resolutions**.

AJ Bell

AJ Bell should notify you about Shareholder Voting at the General Meeting via email. Click 'Vote Now' in the email to be taken to the AJ Bell website (note this can only be done via desktop PC or laptop). You will then be directed to a page where you can **vote against all the Resolutions**.

Not received an email?

Log in to your account on the AJ Bell website (desktop PC or laptop only), select your investment account (ISA, SIPP, JISA, GIA etc), and select 'Voting Instructions' from the Account Menu drop-down box. From this page, you will see voting options and can vote against all the Resolutions by clicking 'Give instruction'. Alternatively, you can contact AJ Bell directly on 0345 543 2600.



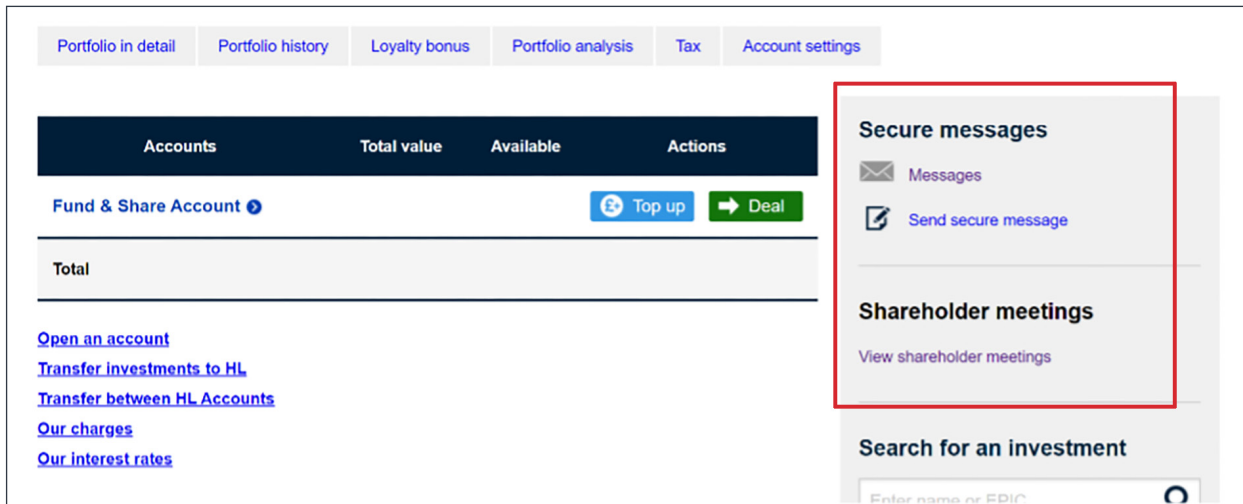
When do I need to vote by?

Please submit your proxy forms as soon as possible. We expect AJ Bell's deadline to be 27 January 2025, after which time your vote may not be counted.

Hargreaves Lansdown (HL)

HL should notify you about Shareholder Voting at the General Meeting via secure message.

You will need to log in to your HL account on the website (note this can only be done via desktop PC or laptop) and either select 'View shareholder meetings' or 'Messages' to see the options to provide instruction to **vote against all the Resolutions**. Alternatively, you can contact HL directly on 0117 321 4173 or send a secure message to **vote against all the Resolutions** via the HL App.



When do I need to vote by?

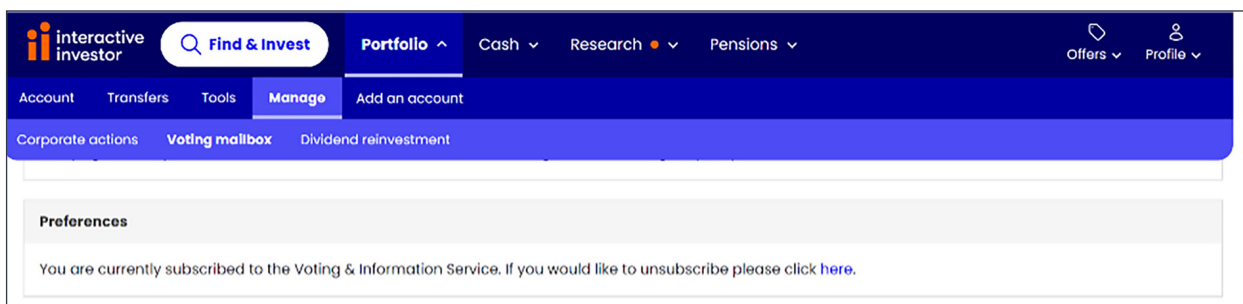
Please submit your proxy forms as soon as possible. We expect HL's deadline to be 28 January 2025, after which time your vote may not be counted.

Interactive Investor (ii)

Interactive Investor should notify you about Shareholder Voting at the General Meeting via secure message.

You are automatically signed up to the voting and information service, which enables you to receive shareholder materials and vote on decisions directly affecting shareholdings.

You will receive notifications via secure message when new documents are available. When you are ready to vote, you need to log in to your account on the website where the options will be presented in the voting mailbox, which sits under the 'Portfolio' tab. This is where you can **vote against all the Resolutions**. Alternatively, you can submit your voting instructions via your Voting Mailbox or contact them directly on 0345 607 6001.



When do I need to vote by?

Please submit your proxy forms as soon as possible. We expect Interactive Investor's deadline to be 29 January 2025, after which time your vote may not be counted.

Halifax Share Dealing (HSDL) / IWeb / Bank of Scotland / Lloyds Stockbroking

HSDL / IWeb / Bank of Scotland / Lloyds Stockbroking should notify you about Shareholder Voting at the General Meeting via email, or by post, depending on your communication preferences.

You can submit your **vote against all Resolutions** by responding to the email or by returning the letter in the stamped addressed envelope. Alternatively you can contact the platform via webchat, or by calling:

When do I need to vote by?

Please submit your proxy forms as soon as possible. We expect HSDL's deadline to be 30 January 2025, after which time your vote may not be counted.

Barclays Smart Investor

Barclays should notify you about Shareholder Voting at the General Meeting electronically or via post, depending on your communication preferences.

You will need to contact Barclays Smart Investor via phone on 0800 279 3667, or by secure chat (once logged into their account on the website) to **vote against all the Resolutions**.

When do I need to vote by?

Please submit your proxy forms as soon as possible. We expect Barclays Smart Investor's deadline to be 27 January 2025, after which time your vote may not be counted.

HSBC

HSBC should notify you about Shareholder Voting at the General Meeting electronically or via post, depending on your communication preferences.

To **vote against all the Resolutions**, you will need to contact HSBC by calling the Share Dealing Help Desk on 03456 080 848 or by logging on to your Online Banking account on the website (desktop PC or laptop only) and sending a secure message.

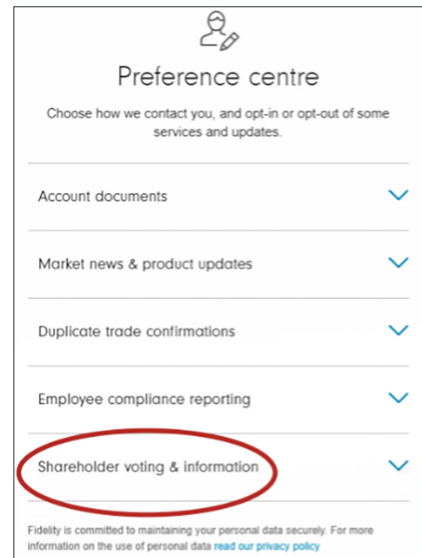
When do I need to vote by?

Please submit your proxy forms as soon as possible. We expect HSBC's deadline to be 29 January 2025, after which time your vote may not be counted.

Fidelity Personal Investing

Fidelity Personal Investing would not normally notify you about Shareholder Voting at General Meetings until you have signed up to the Broadridge UK Voting and Information Rights Service.

To do this, you need to log in to your online account on the website (desktop PC or laptop only) and adjust your preferences. From 'Profile' go to the 'Preference Centre' and click on 'Shareholder voting & information'. Once there, turn on notifications and follow the activation instructions sent via email. Once completed, you will have access to the Global Proxy Voting Portal, where you can then view the details of the General Meeting and **vote against all the Resolutions**. Alternatively, you can contact them directly on 0800 41 41 61.



When do I need to vote by?

Please submit your proxy forms as soon as possible. We expect Fidelity Personal Investing's deadline to be 27 January 2025, after which time your vote may not be counted.

Charles Stanley Direct

Charles Stanley Direct would not normally notify you about Shareholder Voting at General Meetings.

You will therefore need to log on to your account on the website (desktop PC or laptop only) and send a secure message to **vote against all the Resolutions**. They cannot accept email or telephone instruction.

When do I need to vote by?

Please submit your proxy forms as soon as possible. We expect Charles Stanley Direct's deadline to be 27 January 2025, after which time your vote may not be counted.

Best Invest

Best Invest would not normally notify you about Shareholder Voting at General Meetings.

You will therefore need to contact Best Invest via secure message on the website (desktop PC or laptop only), via email at Best@bestinvest.co.uk (FAO the Proxy Voting team) or by post (Bestinvest, 2nd floor, Royal Liver building, Liverpool, L3 1NY) to **vote against all the Resolutions** or to provide you with a letter of representation to attend and vote at the General Meeting in person. If you experience any issues, call the client team on 020 7189 9999.

When do I need to vote by?

Please submit your proxy forms as soon as possible. We expect Best Invest's deadline to be 24 January 2025, after which time your vote may not be counted.

What to tell your platform

To make it even easier to vote against the proposed resolutions, here's a pre-written template that you can send to your platform to vote.

'I am a shareholder in Henderson Opportunities Trust and would like to instruct you to vote my shares by proxy in advance of the General Meeting on 4th February 2025. I would like to vote against all of the proposed resolutions. Please confirm once my proxy vote has been submitted.'
