**Notice of important changes to Henderson UK-domiciled funds**

As part of our continued integration plans post the merger of Janus Capital and Henderson Global Investors, we will be making the following changes to all of the Henderson UK-domiciled funds.

From **15 December 2017**:

- All Henderson fund names will become Janus Henderson (e.g. Henderson All Stocks Credit Fund becomes Janus Henderson All Stocks Credit Fund)
- All Henderson fund umbrella structures will become Janus Henderson (and the respective compartments) (e.g. Henderson OEIC becomes Janus Henderson OEIC)

A schedule of all the fund name changes is attached for your reference.

The affected compartments publicly offered in Belgium are:

Henderson Global Equity Income Fund (Henderson Investment Funds OEIC);  
Henderson Credit Alpha Fund (Henderson Strategic Investment Funds);  
Henderson Global Care Growth Fund (Henderson Global Care Funds)

**Why are we making these changes?**

We are changing the fund and umbrella names to align them with our name Janus Henderson Investors. We will be making similar changes to the Janus and Henderson funds domiciled in Luxembourg and Ireland (with the same effective date of 15 December 2017). Separate notifications will be sent in relation to those fund ranges where applicable.

**Are any other changes being made?**

We are taking the opportunity to make a number of fund specific changes to coincide with the 15 December 2017 name change date. If you are invested in any of the affected funds further details will be enclosed with this letter.

### **Are any operational changes being made?**

Not at this time. DST Financial Services International Limited (formerly IFDS) remains the administrator for the UK-domiciled fund range. Email addresses and websites have been amended to reflect the addition of “Janus” into our new corporate name.

The legal entities appointed to run the fund are not being renamed at this point. Henderson Investment Funds Limited remains the Authorised Corporate Director/Unit Trust Manager and ISA Plan Manager and Henderson Global Investors Limited remains the Investment Manager/Adviser.

### **Will contact details be changing?**

- Telephone numbers stay the same.
- Addresses stay the same, although the initial line now refers to Janus Henderson Investors.
- Henderson has been replaced by janushenderson on web addresses and emails.
