**Advance notice of the declaration of a number of non-dealing days for certain sub funds of the Janus Henderson Horizon Fund**

Dear Shareholder,

We are writing to you to provide you with advance notice that due to a three-day 'Golden Week' holiday period in Japan, non-dealing days will be declared on certain Funds within the Janus Henderson Horizon Fund SICAV ("the Company") from Monday 4 May until Wednesday 6 May 2020 inclusive. In addition, Friday 1 May 2020 is a Luxembourg bank holiday (not a Luxembourg Business Day) and therefore not a Dealing Day. This means that you will be unable to buy, sell or switch shares in these Funds during the period. The Funds will reopen for dealing on Thursday 7 May 2020. The impacted Funds are:

- **Janus Henderson Horizon Fund – Asia Pacific Property Equities Fund**
- **Janus Henderson Horizon Fund – Japan Opportunities Fund**
- **Janus Henderson Horizon Fund – Japanese Smaller Companies Fund**

(collectively the "Funds")

The Golden Week is a national holiday which occurs annually. As a result, all Japanese securities markets and banks will be closed for three business days. We have decided that as the Funds will be unable to implement any investment decisions or raise cash that it is in the interest of all investors to not allow dealing in shares in the Funds during this holiday period.

**Any deals received during this period will be held over and processed on 7 May 2020 when dealing in the Funds resumes. You will not need to reinstruct your trade.**

The last Dealing Day and Dealing Cut-Off before this period will be 1.00pm Luxembourg time on Thursday 30 April 2020. Dealing in shares in the Funds will resume on Thursday 7 May 2020.

***As permitted under the terms of the Prospectus, delays in settling redemptions received by the Funds between 1pm on 27 April and 1pm on 30 April may also arise as a result of the 'Golden Week' holiday period.***

No other funds in the Company are impacted by this.

We would like to apologise for any inconvenience this may cause but believe this is the best course of action to take.
