The Fund invests at least 80% of its net assets in equities and equity-related instruments of biotechnology and biotechnology-related companies worldwide. "Biotechnology and biotechnology-related companies" is defined as:</p> <ul style="list-style-type: none"> <li>• companies that are included in the NASDAQ Biotechnology Index;</li> <li>• companies that develop small molecule or biologic drugs subject to the approval of global regulatory agencies;</li> <li>• companies that market products or services to aid in the research and development of small molecule or biologic drugs; or</li> <li>• companies that are considered such by the Investment Manager.</li> </ul> <p>In choosing investments, the Investment Manager aims to select biotechnology companies that he or she believes to be undervalued, with greater potential for clinical and/or commercial success than is currently reflected in market prices. The Fund may invest in companies of any size, including smaller capitalisation companies. Equity-related instruments may include depository receipts and derivative instruments (such as futures, forwards, equity swaps (also known as contract-for-differences), swaps and options and warrants). The Fund may use derivative instruments for investment purposes (up to 10% of its net assets) and hedging purposes. The underlyings consist of a range of securities or indices that the Fund may invest in according to the Fund's investment objective and policy.
