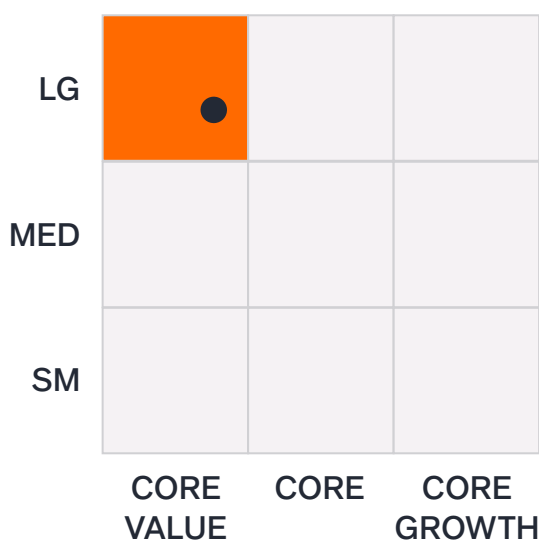
Superior companies with established track records that are priced at a level that does not reflect their intrinsic value or prospects.
