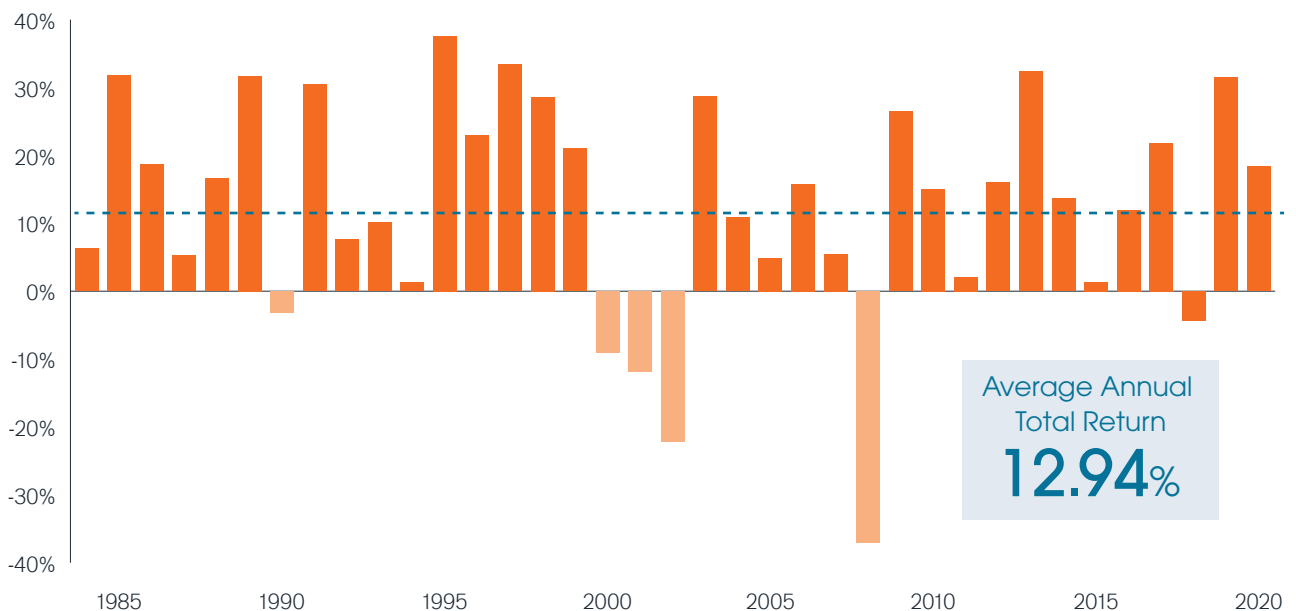

What are Your Expected Returns?

While the average annual total return for the stock market over the last 36 years is 12.94%, investors who anticipate this kind of consistent growth on a year-over-year basis may be in for a surprise. That's because almost 42% of the time, from 1984 to 2020, the market ended the year with a gain or a loss of more than 20%.
